REGARDING COVID 19 AND OTHER CONTAGIOUS DISEASE:

The Korinji Foundation, International Shugendo Association, and Koryu Shugen Honshu cannot guarantee that participants, volunteers, partners, or others in attendance at this event will not become infected with COVID-19 or other contagious diseases.
